#### Other New Business:

- Brian D'Souza has been approached by the Merchant Marines. Is there a method for them to be eligible? We will have to take that as an action item and determine the eligibility.
- Charlie Novatny brought up question about dates for the ASSC because of Mothers' Day, the Masters, and also graduation weeks for cadets and college students.
  - Brad Felton asked if it's possible to change the dates for 2023 so that the cadets and colleges can attend.
  - o ASSC is not tied to the Masters.
  - The vote for 2023 location was based on the bids as proposed. Peoria will not move as they have another shoot scheduled
- Charlie Novotny made a motion that AFSA is prescriptive with two weeks when
  requesting bids for the ASSC and that the AFSA Officers will specify in the call for bids
  the two weeks that we want to host the ASSC. The club can select one or both of the
  weeks as primary, alternate, or either are applicable. Steve Johnstone seconded that
  motion.
  - There have been discussions multiple times of reviewing when else the shoot can be held to avoid Mothers' Day
  - 2-3 weeks before Memorial Day usually conflicts with finals week for colleges but the week before Academy graduations is an option for one of the weeks
  - o It was noted that cadets and college shooters are 10% of the ASSC population, and we need to be aware when changing the format, week of execution, etc

- Bids next year need to have multiple weeks proposed and then the votes will be the club and then the date
- o In the future we could have a situation where we are all voting for the same club but voting between dates the shoot is held
- Motion passed unanimously.
- This motion is consistent with the current bid process; however it highlights the flexibility for prospective clubs to consider two weeks and the prior weekend to host the Pletcher and the ASSC.
- Ron Hostinksy thanked Darron Todd for the chief referee efforts and Corrie Cloninger and Alison Boyette for doing a phenomenal job.
- Mike Lee brought up a question about shootoffs and how classes and concurrents are shot off.
  - o Discussion ensued about various options and the various softwares
  - Also discussed the intent behind shootoffs at the ASSC to ensure that all prizes are shot off and also new shooters have a good experience.
  - Lastly, we discussed that training referees for the shoot off format is key to ensure they have the tools they need to be successful.
  - Every year shootoffs are being refined to be better. It takes time to train these folks and make sure that they know how to conduct these. Everyone is working to make this better.
- Mike Lee brought up a question about drop outs and ensuring that prizes are accurate for the Group 2 and 3 individuals as the population changes?
  - Andy validated that this was occurring and Group 2 and 3 shooters were given prizes if the program states as such.
- Brian D'Souza mentioned the opportunity that AFSA has to sponsor younger shooters and help individuals attend. Chris Naler added that there are a few options:
  - o Individuals can donate money that is earmarked for specific new shooters. This can be used for shoot fees, but not hotels, ammo, etc.
  - Instead of getting paid by targets for referring, we could put that money on the account
  - o Lastly, the Horton family donated 5 scholarships per year.
  - o We should not donate to any shooter directly. We should use the association
- Chris Naler asked if everyone was comfortable having a tiered / sequenced registration for ASSC members and then gusts as feasible
  - No issues or concerns were raised
  - o Guest entry fees would be targets only and about \$10 less
  - o Likely will be a 6-8 week gap in registration
  - Brad Felton asked about having more than 2.5% in attendance that are not members. To answer this question requires Katie to determine the AFSA Membership and then we can make a decision on how this is classified.
  - One question would non-member shooters have to pay state fees?

- Ron Hostinsky proposes a motion that the Ironman referees are given a set price per day
  rather than by target or round. This would give them the pay even if there is a hole in
  their fields.
  - Andrew Winders seconds the motion
  - o Chris asked Ron to give Andy the freedom to set the amount based on costs
  - Motion amended to recommend allowing the Treasurer to make that rate based on the # of flights each day.
  - o Andrew Winders approved the amendment
  - o Brad Felton and Fred Tschantz voted against; all others voted for the motion
  - Motion passed
- Don Kelly reminded the Directors that NSSA provides World entries for Zone 9 for first time attendees. It's not necessary that those shooters attend the ASSC but it is preferred.

Mike Lee made a motion to adjourn the meeting. Charlie Novotny seconded.
